

# Yngling Open Springtime European Championship

## Riva del Garda – Italy

### 4<sup>th</sup> May – 6<sup>th</sup> May 2017

## NOTICE OF RACE

### DATE, VENUE AND ORGANISING AUTHORITY

The Yngling Open Springtime Championship will be held at Riva del Garda from 4<sup>th</sup> to 6<sup>th</sup> May 2017. The Organising Authority for the regatta is the Fraglia Vela Riva in association with World Sailing (WS), the Italian Sailing Federation (FIV), the International Yngling Class Association and the Yngling Club Österreich.

### ELEGIBILITY

The ISAF Eligibility Code will apply.

A boat entered in the regatta must meet the class rules for membership of the class association.

All members of Italian crews must have an Italian Sailing Federation membership card valid for year 2017.

### SCHEDULE

4 <sup>th</sup> May	from 9.00 to 12.00	Completion of registration and launching
4 <sup>th</sup> May	at 13.00	First warning signal
5 <sup>th</sup> May		Race(s)
6 <sup>th</sup> May		Race(s)– Prize Giving, as soon as possible after the end of the last race

Eight (6) races are scheduled.

Rescheduling of races may be made at the discretion of the Race Committee.

Races not completed as scheduled may be sailed at a later time or day during the regatta.

However, not more than three races per day will be scheduled.

Any changes to the start time will be posted on the clubhouse notice board by 20.00 hrs of the preceding day.

No warning signal will be given after 16.00 hrs on the last day of the regatta.

Social Event Programme will be available at on-site registration.

### RULES

The regatta will be governed as defined in RRS.

### PENALTY

In the Yngling Class, the Two-Turns penalty for breaking a rule of Part 2 of the RRS as described in RRS 44.1 will be replaced by the One Turn penalty as described in RRS 44.2.

### ENTRY

Entry forms must be sent on-line through the website [www.fragliavelariva.it](http://www.fragliavelariva.it).

The entry form must be filled in paying attention to the unavoidable fields in red and sent to FVR clicking on SEND at the bottom of the entry form. All entries when confirmed will be displayed on the event website.

Inclusion on this notice can be considered as acceptance of entry

### ENTRY FEES

Entry fee is fixed in € 180,00 for **25 or more boats well entered**, per boat and includes crane facilities, club facilities and “pasta” after races. If there would be less than 25 boats well entered, at the entry fee will be charged € 20. For boats with a crew, all members were born after the 1<sup>st</sup> of January 1994, the entry fee is € 170,00.

The above mentioned fee must be paid through the website by PayPal; in cash or with credit card at on-site registration at the race office of Fraglia Vela Riva prior competing in the Regatta or through bank transfer:

Only Euro currency is acceptable.

### MEASUREMENTS AND CHECKS

Each participating boat shall have and carry a valid Measurement Certificate.



Yachts and sails must be in conformity with the Rules of the Class Associations.  
The Race Committee may check yachts and crews before or during or after the races.

**SAILING INSTRUCTIONS**

The Sailing Instructions will be available at the regatta office from May 4<sup>th</sup> 2017 and will be given at registration.

**SCORING SYSTEM**

The Low Point scoring system of RRS Appendix A will apply.  
If 5 or more races are completed, boats may discard their worst score.

**ADVERTISING**

Advertising is permitted as from Class Rules.

**PRIZES**

Prizes will be awarded at least to the first three (3) placed boats of the “overall ranking”.

**LIABILITIES**

It is the competitor’s decision to enter the regatta or to start and continue in any race.  
Competitors shall accept that their participation in the regatta is at their exclusive risk in every respect.  
See RRS Rule 4, Decision to Race. The Organising Authority and the respective Host Sailing Club, their officers, members, servants and agents accept no responsibility in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in the regatta or howsoever arising in connection with the regatta.

**INSURANCE**

All boats competing in the regatta 2017 shall have third party insurance cover of **not less than € 1.500.000,00 or equivalent thereof in any other currency for any accident.**

All owners/competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover.
