# NOTICE OF RACE

# DATE, VENUE AND ORGANISING AUTHORITY

The 29er Euro Cup regatta will be held at Riva del Garda from 27<sup>th</sup> October to 30<sup>th</sup> October 2016. The Organising Authority for the regatta is the Fraglia Vela Riva in association with the 29er Class Association, the Italian Sailing Federation (FIV) and the International Sailing Federation (WS).

# ELEGIBILITY

The ISAF Eligibility Code will apply. A boat entered in the regatta must meet the class rules for membership of the class association. All members of Italian crews must have an Italian Sailing Federation membership card valid for year 2016.

# SCHEDULE

A maximum of 14 races will be sailed, up to 4 per day. One discard with four valid races. Two discards with 9 or more valid races.

3 races are required to constitute a EuroCup.

Rescheduling of races may be made at the discretion of the Race Committee.

Races not completed as scheduled may be sailed at a later time or day during the event.

However, not more than four races per day will be sailed.

Any changes to the start time will be posted on the clubhouse notice board by 20.00 hrs of the preceding day.

No warning signal will be given after 15.00 hrs on the last day of the regatta.

Social Event Programme will be available at on-site registration.

# RULES

The regatta will be governed as defined in RRS.

RRS 44.2 is amended so that the two turns is replaced by one turn, including one tack and one gybe. Sailing Instructions, this Notice of race, The Notice of series 2016 <u>http://www.29er.org/events/eurocup</u>

# ENTRY

Entry forms must be sent on-line through the website <u>www.fragliavelariva.it</u> All entries when confirmed will be displayed on the event website. Inclusion on this notice can be considered as acceptance of entry. Sailors who are not current members prior to the first race of each event will not be scored

# ENTRY FEES

Entry fee is fixed in € 150,00 per boat. The above mentioned fee must be paid in cash, with credit card at on-site registration at the race office of Fraglia Vela Riva prior competing in the Regatta Paypal System or Credit Card Payment System or through bank transfer: FRAGLIA VELA RIVA DEL GARDA

#### MEASUREMENT

Hulls and sails must be in conformity with the Rules of the Class Associations. The Race Committee may check all boats and crews before, during and after the races.

#### SAILING INSTRUCTIONS

The Sailing Instructions will be available at the regatta office from 9.00 of the 27<sup>th</sup> October 2016.

# SCORING SYSTEM

The Low Point scoring system of RRS Appendix A will apply.

#### ADVERTISING

Advertising is permitted as from Class Rules, as per ISAF Regulation 20.

#### PRIZES

Prizes will be awarded at least to the first three (3) placed boats.

# **OVERALL SCORING (29ER EUROCUP 2016)**

as required by Notice of Series of 29<sup>er</sup> Eurocup 2016 point 8.11. "The final event in Garda will be non-discardable".

A minimum of 5 boats must be registered from a minimum of 2 nations for the EuroCup to be scored in the Series. For the purpose of series scoring, results will be based off the team's performance (ie: both helm & crew must be consistent throughout the entire EuroCup series.) Change of helm or crew will result in a separate listing.

#### LIABILITIES

It is the competitor's decision to enter the regatta or to start and continue in any race.

Competitors shall accept that their participation in the regatta is at their exclusive risk in every respect.

See RRS Rule 4, Decision to Race. The Organising Authority and the respective Host Sailing

Club, their officers, members, servants and agents accept no responsibility in respect of loss of life,

personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in the regatta or howsoever arising in connection with the regatta.

#### **RIGHT TO USE NAME AND LIKENESS**

In participating in the 29er Euro Cup any competitor automatically grants to the Organising Authority and the sponsors of the 29er Euro Cup the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said 29er Euro Cup in which the competitor participates and in all material related to the said 29er Euro Cup without compensation.

#### INSURANCE

All boats competing in the regatta 2016 shall have third party insurance cover of not less than €1.500.000,00 or equivalent thereof in any other currency for any accident.
