**ELIGIBILITY**

The regatta will be open to all competitors who were born between **2005** and **2011**. According to Italian law and FIV Regulations, competitors will be classified as follow:

- “Cadetti” Division A born in years 2010 and 2011;**
- “Juniore” Division B born from 2005 to 2009.**

The “Cadetti” fleet will be racing under the rules of the Italian Sailing Federation;

1. Time on the water will not exceed 7 hours per day
2. No more than three races per day.

Other rules that will apply will be posted on the official notice board not later the 20:00 hours on August 18<sup>th</sup>.

- Italian sailors shall carry to the Organizing Authority a current and valid 2020 F.I.V. membership card;
- each sailor shall be current members of their National Class Association (A.I.C.O. for Italian sailors)
- all sailors shall have third party insurance cover of not less than **€ 1.500.000,00** and are required to produce evidence of such insurance during registration;
- all boats shall lodge a valid measurement certificate;

**RACING RULES**



The regatta will be governed by the Rules as defined in the RRS (Racing Rules for Sailing).  
The national authority prescriptions will apply.

#### ADVERTISING

Advertising is not permitted except as provided in WS Regulation 20.  
Competitors may be required to display advertising stickers. The stickers, which will be provided by the Organizing Authority, shall be displayed from 10:00 August the 20<sup>th</sup> until two hours after the last race.

#### RACES AND SCORING

The Organizing Authority will set racing area, further information will be available in Sailing Instructions.  
The Low-Point scoring system will apply to both divisions.

##### “Cadetti”:

The race will be sailed dividing the competitors into heats.  
Eight (8) races are scheduled from 20<sup>th</sup> to August 23<sup>th</sup>.  
When 4 or more races have been completed, a boat’s series score will be the total of her race scores excluding her worst score.

##### “Juniores”:

The race will be sailed dividing the competitors into heats.  
At registration competitors will be seeded into groups. Normally during the last racing day, finals will be sailed, if 4 or more races have been completed.  
Nine (9) races are scheduled from 20<sup>th</sup> to August 23<sup>th</sup>.  
When 4 or more races have been completed, a boat’s series score will be the total of her race scores excluding her worst score.

## ENTRIES PROCEDURE:

The entry form must be filled-in paying attention to required fields in red and sent clicking on SEND at the bottom of the entry form. All entries when confirmed will be displayed on the event’s website. Competitors must confirm the registration sending all documents listed in the registration part to: [race@fragliavelariva.it](mailto:race@fragliavelariva.it) **within the 10<sup>th</sup> of August.**

#### ENTRY FEE

The price for registrations after the reopening of the procedure till 26<sup>th</sup> of July is 100€, from 27<sup>th</sup> of July to 10<sup>th</sup> of August the cost will be 120€.

All sailors with a valid registration from the first round of registration are requested to send all the documents, **written in the registration part in this NOR, within the 20<sup>th</sup> of July in order to confirm their registration and help the Organizer to check the trend of the number.**

**A maximum number of 800 sailors is fixed.**

**After the 10<sup>th</sup> of August 2020 any request to join the event WILL NOT BE ACCEPTED IN ANY CASE.**

### CANCELLATION & REFUND

50% of the entry fee paid is refundable for cancellations received by the 20<sup>th</sup> of July. No entry fee is refundable after the 20<sup>th</sup> of July.

### INSURANCE

Italian sailors and foreign sailors shall have third party insurance covering of not less than € 1.500.000,00 as per the new prescription of WS and the Italian sailing Federation (Prot 2015-1055).

All competitors at the registration are required to produce evidence of such insurance written in Italian or English and clearly indicating the name of the sailor(s) or the sailing number(s) or the IODA registry number(s) of the insured boat(s), including the starting date and ending date of the insurance and the euro/USD amount of the insurance.

If an insurance is issued to a sail number/IODA registration number, the competitor shall present a valid measurement certificate and will not be allowed to sail with a sail number different from the one printed on the measurement certificate.

### REGISTRATIONS

At the moment Italian Sailing Federation (FIV) does not allow the completion of registrations at the secretary office.

**All documents MUST BE SENT to [race@fragliavelariva.it](mailto:race@fragliavelariva.it) within the 10<sup>th</sup> of August.**

**The documents needed are:**

- Italian sailors shall send to the Organizing Authority a current and valid 2020 F.I.V. membership card;
- membership of the National Class Association (A.I.C.O. for Italian sailors);
- third party insurance cover of not less than € 1.500.000,00
- a valid measurement certificate.
- Parental Form, you can download it on our website
- Self-certification , you can download it on our website

### MEASUREMENT CHECK

Measurement checks may be carried out before or after racing. All the equipment may be measured.

### SAILING INSTRUCTIONS

Sailing Instructions will be available online the 19<sup>th</sup> of August.

### INTERNATIONAL JURY

Decisions of the international jury will be final as provided in RRS 70.5.

to RRS 70.5 and Appendix N. The decisions of the International Jury will be final and the right to appeal will be denied (RRS 70.5 C).

### SUPPORT BOATS AND MOTOR NAVIGATION

Mechanically propelled boats are generally prohibited to run on the northern part of Lake Garda, however, during this event, a special permit to use such boats may be given. Support personnel having a boat, shall produce the following documents to the Organizing Authority:

- rib's engine registration document (engine brand name - engine serial numbers);
- rib's engine insurance;
- driver's identity document

All the listed documents must be sent to [race@fragliavelariva.it](mailto:race@fragliavelariva.it).

The permit will be issued only for assistance to the races and training and it can be withdrawn at any time if rules for coaching as stating in the SI will be not followed. It is forbidden the navigation of private assistance boats on the right-hand side of the course looking south.

### COACHES, AID AND SAFETY

Team leaders/coaches shall register at Secretary Office.

Team leaders/coaches shall comply with the following:

- to follow all instructions given by the Race Committee and by the Organizing Committee;
- to carry other coaches on board if necessary;
- **not more than 2 coaches/trainers/parents are allowed on the same assisting rubber boat;**
- Enter the clubhouse only after checking body temperature
- Access in nautic facilities only for Race Committee, athletes, measurers
- No access to locker room
- In closed spaces always wear masks
- Always keep social distance 1m
- The Organizing Authority reserves the right to assign a different area to each team
- Follow all the rules published by the Organizer, according to Italian and FIV regulations

The event will take place in Riva del Garda on 2020, August 19<sup>th</sup>.

#### **ELIGIBILITY**

The regatta will be open to all competitors who were born between **2005** and **2011**.

- Italian sailors shall carry to the Organizing Authority a current and valid 2020 F.I.V. membership card;
- each sailor shall be current members of their National Class Association (A.I.C.O. for Italian sailors);
- all sailors shall have third party insurance cover of not less than € 1.500.000,00 and are required to produce evidence of such insurance during registration; It will be possible to buy the insurance at the race office;
- all boats shall lodge a valid measurement certificate;

Only one sailor per country will be allowed. The sailors will be indicated by Optimist National Class of their country not later than midnight of 2020, August 19<sup>th</sup>. If none will be indicated the OA of the event will choose the sailor. This will not be ground for request of redress and this change the RRS 62.1a.

Stickers with national colors will be given by the OA and may be attached on the top of the sails behind the Optimist logo.

No score will be excluded.
