## BANDO DI REGATA / NOTICE OF RACE Rev

**All the participants to regatta's activities are conscious of prescriptions regarding the containment and the contrast of COVID 19, written in the Italian Sailing Federation (FIV), and they commit to follow them in the consciousness that potential negative behaviors are against these specifics dispositions and they can be noticed and reported to the Authority in charge by the Organizing Committee.**

DP Rules for which penalties are upon the Protests Committee. Depending on the seriousness of the breach of point 1.h, the penalty may be from a minimum of 10% to a disqualification.

NP Rules that may not be ground of protests between boats (this changes RRS60.1(a))

### RULES

- a) The race will be governed by the Rules as defined in the Racing Rules of Sailing (RRS) 2017-2020, by the Normativa FIV per l'Attività Sportiva Nazionale 2020 with the prescriptions which have to be considered "rules"
- b) Class rules
- c) NOR, SI and the following Notices will be posted on the notice board. In case of conflict between NOR, SI and notices, the SI and the following notices shall prevail (this change RRS 63.7)
- d) Advertising is allowed in accordance with WS Regulation 20 - Advertising Code
- e) Boats may be required to display Event Advertising on the forward part of the hull [DP] [NP]
- f) Give the right-of-way to public boats in service on the lake.
- g) In case of conflict the English language will prevail.
- h) The "PROTOCOLLO DI REGOLAMENTAZIONE DELLE MISURE PER IL CONTRASTO ED IL CONTENIMENTO DELLA DIFFUSIONE DEL COVID-19 NELLE SOCIETÀ E ASSOCIAZIONI SPORTIVE AFFILIATE", the update version on the 14th June or upcoming, is defined from here on as "protocol". A breach of protocol may be a [DP] breach

### VENUE:

Riva del Garda - Lake Garda - Italy

### PROGRAMME:

9 races are scheduled. With 4 races sailed there will be 1 discard.

First warning signal: **9 October at 12.00**. On the last day of the regatta no warning signal will be made after 4.00pm.

### **RULES AND ADVERTISING:**

RRS, Class Rules, Notice of Race, the Sailing Instructions and any amendments thereto which will be available at registration. Advertising is permitted in accordance with Class Rules, as per WS Regulation 20.

In case of conflict between NoR and SI, the Sailing Instructions and following Notices will prevail (this changes RRS 63.7). In case of conflict between languages, the Italian version of this NoR shall prevail.

### **ELIGIBILITY:**

Admitted class: OPTIMIST (Juniors born 2005 – 2009, Cadetti born 2010 - **2011**)

All optimist sailors are eligible, subject to the following:

Italian sailors shall carry a current and valid 2020 F.I.V. membership card, a current members of their National Class Association; all sailors shall have third party insurance cover of not less than € 1.500.000,00.; all boats shall have a valid measurement certificate.

### **LIABILITY:**

Competitors will sail under their own risk. Fraglia Vela Riva and all Race Committees and the Jury decline any responsibility to persons or goods, at sea or ashore, in consequence of participation in the competitions. The competitors and/or the parents or tutors shall contract all insurances required to cover every risk, included that to a third party.

### **SCORING SYSTEM:**

Low-point scoring system will apply.

### **PRIZES:**

cadetti – general ranking - from 1<sup>st</sup> to 5<sup>th</sup> classified. Cadetti female – from 1<sup>st</sup> to 3<sup>rd</sup> classified.

juniors - general ranking - from 1<sup>st</sup> to 5<sup>th</sup> classified. Juniors female – from 1<sup>st</sup> to 3<sup>rd</sup> classified.

Ezio Torboli trophy will be awarded to the club with the low points on the general ranking considering the best 2 Juniors and the best 2 Cadet.

The “**Al Porto**” trophy will be awarded to the first classified Juniors born in 2009.

Draw of special prizes among all the sailors.

### **ENTRIES:**

Entry forms must reach the Fraglia Vela Riva, at least 3 days before the start of the race.

- third party insurance cover of not less than € 1.500.000,00
- a valid measurement certificate.

#### **SUPPORT BOATS AND MOTOR NAVIGATION:**

Mechanically propelled boats are generally prohibited to run on the northern part of Lake Garda, however, during this event, a special permit to use such boats may be given. Support personnel having a boat, shall produce the following documents to the Organizing Authority:

- rib's engine registration document (engine brand name - engine serial numbers);
- rib's engine insurance;
- driver's identity document.
