VENUE AND DATE

The event will take place in Riva del Garda from September 11 to September 13 2020

ELEGIBILITY

The WS Eligibility Code will apply. A boat entered in the regatta must meet the class rules for membership of the class association. All members of Italian crews must have an Italian Sailing Federation membership card valid for year 2020.

SCHEDULE

11 September	at 12.30	First warning signal
12 September		Race(s)
13 September		Races(s) – Prize Giving as soon as possible after the end of the last race

Eight races are scheduled.

Rescheduling of races may be made at the discretion of the Race Committee.

Races not completed as scheduled may be sailed at a later time or day during the championship.

Not more than three races per day will be scheduled. If scheduled races of a previous day have not been completed, the Race Committee at its discretion may add one more race per day.

Any changes to the start time will be posted on the clubhouse notice board by 20.00 hrs of the preceding day.

No warning signal will be given after 15.30 hrs on the last day of the regatta.

RULES

The regatta will be governed by the Rules as defined in the RRS (Racing Rules for Sailing). Class Rules. Italian National prescription will apply.

The protocol of regulation in measures for contrast and against the spread of Covid-19 in sport society and sport association, updated version at 14th June 2020 or eventual following versions. An infraction to the Protocol should be punished with the application of a penalty.

ENTRY

Entry forms must be sent on-line through the website www.fragliavelariva.it.

The entry form must be filled in paying attention to the unavoidable fields in red. All entries when confirmed will be displayed on the event website. Inclusion on this notice can be considered as acceptance of entry

ENTRY FEES

Entry fee is fixed in € 250,00 per boat and includes crane facilities.

In order to complete the registration competitors must send a valid third party insurance cover of not less than € 1.500.000,00 and a valid FIV card if Italians.

MEASUREMENTS AND CHECKS

Each participating boat shall comply with the class rules and the Longtze European Tour 2020 rules. The Race Committee may check all yachts and crews before, during and after the races.

SAILING INSTRUCTIONS

The Sailing Instructions will be available at the regatta office from September the 10th 2020 and will be given at registration.

SCORING SYSTEM

The Low Point scoring system of RRS Appendix A will apply. Eight races are scheduled. If 4 or more races are completed, boats may discard their worst score.

ADVERTISING

Advertising is permitted as from Class Rules.

PRIZES

Prizes will be awarded at least to the first three (3) placed boats.

LIABILITIES

It is the competitor's decision to enter the regatta or to start and continue in any race. Competitors shall accept that their participation in the regatta is at their exclusive risk in every respect. See RRS Rule 4, Decision to Race. The Organising Authority and the respective Host Sailing Club, their officers, members, servants and agents accept no responsibility in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in the regatta or howsoever arising in connection with the regatta.

RIGHT TO USE NAME AND LIKENESS

In participating in the Longtze Alp Trophy any competitor automatically grants to the Organising Authority and the sponsors of the Longtze Alp Trophy the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said Longtze Alp Trophy in which the competitor participates and in all material related to the said Longtze Alp Trophy without compensation.

INSURANCE

All boats competing in the regatta 2020 shall have third party insurance cover of not less than € 1.500.000,00 or equivalent thereof in any other currency for any accident. All owners/competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover.

SUPPORT BOATS AND MOTOR NAVIGATION:

Mechanically propelled boats are generally prohibited to run on the northern part of Lake Garda, however, during this event, a special permit to use such boats may be given. Support personnel having a boat, shall produce the following documents to the Organizing Authority:

- rib's engine registration document (engine brand name - engine serial numbers);
- rib's engine insurance;
- driver's identity document.
