All the participants to regatta's activities are conscious of prescriptions regarding the containment and the contrast of COVID 19, written in the Italian Sailing Federation (FIV), and they commit to follow them in the consciousness that potential negative behaviors are against these specifics dispositions and they can be noticed and reported to the Authority in charge by the Organizing Committee.

2. VENUE AND DATE

The events will take place in Riva del Garda from the 6th to the 8th December 2020.

3. RULES

3.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).

3.2 RSS Appendix P, Special Procedures for Rule 42, will apply.

3.3 FIV prescriptions will apply.

3.4 If there is a conflict between languages the English text will take precedence.

3.5 All competitors will be required to wear an adequate personal flotation device at all times while afloat, except briefly while changing or adjusting clothing or personal equipment. The race will be governed by the Rules as defined in the Racing Rules of Sailing (RRS) 2017-2020, by the

3.6 Class rules

3.7 NOR, SI and the following Notices will be posted on the notice board. In case of conflict between NOR, SI and notices, the SI and the following notices shall prevail (this change RRS 63.7)

3.8 Advertising is allowed in accordance with WS Regulation 20 - Advertising Code

3.9 Boats may be required to display Event Advertising on the forward part of the hull [DP] [NP]

3.10 Give the right-of-way to public boats in service on the lake.

3.11 The "PROTOCOLLO DI REGOLAMENTAZIONE DELLE MISURE PER IL CONTRASTO ED IL CONTENIMENTO DELLA DIFFUSIONE DEL COVID-19 NELLE SOCIETÀ E ASSOCIAZIONI SPORTIVE AFFILIATE", the update version on the 14th June or upcoming, is defined from here on as "protocol". A breach of protocol may be a [DP] breach

4. ADVERTISING and BOW NUMBERS [NP][DP]

4.1 Boats may be required to display bow numbers and advertising chosen and supplied by the organizing authority.

5. ELIGIBILITY AND ENTRY

5.1 Competitors and coaches shall enter by completing the on-line entry form on the event website https://www.fragliavelariva.it/en/regattas/

Entry in the event is not final until registration is completed.

5.2 Competitors under 18 years of age shall present a signed and completed parent (or

guardian) consent and declaration form at registration. The forms are available for

download on the event website https://www.fragliavelariva.it/en/regattas/.

5.3 The regatta is open to Laser Standard, Laser Radial and Laser 4.7

6. RACES AND SCORING

The Organizing Authority will set racing area, further information will be available in Sailing Instructions.

The Low-Point scoring system will apply to all fleet.

9 races are scheduled.

7. ENTRY AND REGISTRATIONS

Entry forms must reach the Fraglia Vela Riva, at least 3 days before the start of the race.

All documents MUST BE SENT to info@fragliavelariva.it within the 1st of December.

The documents needed are:

- Italian sailors shall send to the Organizing Authority a current and valid 2020 F.I.V. membership card;
- third party insurance cover of not less than € 1.500.000,00
- Parental Form, you can download it on our website
- Self-certification , you can download it on our website

8. CANCELLATION & REFUND

50% of the entry fee paid is refundable for cancellations received by the 15th of November. No entry fee is refundable after the 16th of November 2020.

9. INSURANCE

Italian sailors and foreign sailors shall have third party insurance covering of not less than € 1.500.000,00 as per the new prescription of WS and the Italian sailing Federation (Prot 2015-1055).

All competitors at the registration are required to produce evidence of such insurance written in Italian or English and clearly indicating the name of the sailor(s) or the sailing number(s) including the starting date and ending date of the insurance and the euro/USD amount of the insurance.

10. SAILING INSTRUCTIONS

Sailing Instructions will be available online the 5th of December.

11. PRIZES

First 3 overall for each class.

First 3 girls in Laser Radial and Laser 4.7.

Trofeo Paola will go to the team with lower score of the 2 best participants in each class.

12. LIABILITY

It is up to parents, team leaders or support person to allow competitors to take part in the races and therefore they have to sign the declaration of participation on registration. Fraglia Vela Riva, the Race Committee, the Jury and all volunteers involved decline all responsibility regarding persons or goods, at sea or ashore, in consequence of participation in the competition. Competitors shall have all insurances required to cover every risk, including risk to a third party.

13. SUPPORT BOATS AND MOTOR NAVIGATION





Mechanically propelled boats are generally prohibited to run on the northern part of Lake Garda, however, during this event, a special permit to use such boats may be given.

Support personnel having a boat, shall produce the following documents to the Organizing Authority:

- rib's engine registration document (engine brand name engine serial numbers);
- rib's engine insurance;
- driver's identity document.
