SP	Denotes a rule for which a standard penalty may be applied by the Race Committee or Technical Committee without a hearing, or a discretionary penalty applied by the Protest committee with a hearing. This changes RRS 63.1 and A5.1;
DP	Rules for which penalties are upon the Protests Committee. Depending on the seriousness of a breach of Covid-19 Italian Protocol, the penalty may be from a minimum of 10% to a disqualification.
NP	Rules that may not be ground of protests between boats (this changes RRS60.1(a))

PROGRAMME:

12 races are scheduled. With 4 races sailed there will be 1 discard. Min 4 and max 6 races of qualifying Series and 6 of final series.

First warning signal: 9 March at 12.00. On the last day of the regatta no warning signal will be made after 4.00 pm.

RULES

- The first three sentences of RRS 61.1(a) are changed to 'A boat intending to protest shall inform the other boat at the first reasonable opportunity. When her protest will concern an incident in the racing area that she was involved in or saw she shall hail 'Protest'. She shall inform the Race Committee at the finishing line immediately after finishing of the boat/s being protested, or as soon as practicable after she retires.'

- [NP][DP] Rule 40 and the preamble to Part 4 are changed as follows: The first sentence of rule 40 is deleted and replaced by "Each competitor shall wear a personal flotation device (PFD) according to class rule 4.2 (a), properly secured at all times while on the water except when temporarily adding or removing clothing."

ADVERTISING

- Sailor advertising is permitted on the hull as per World Sailing Regulation 20.3.2 but as restricted by class rule 2.8. 2. Italian sailors must respect Italian Sailing Federation rules.

- Boats may be required to display advertising chosen and supplied by the Organising Authority.

ELIGIBILITY:

Admitted class: OPTIMIST (Juniors born 2008 – 2012 and Cadetti 2013 - 2014)

All optimist sailors are eligible, subject to the following:

Italian sailors shall carry a current and valid 2023 F.I.V. membership card, a current members of their National

Class Association; all sailors shall have third party insurance cover of not less than € 1.500.000,00.

LIABILITY:

Competitors will sail under their own risk. Fraglia Vela Riva and all Race Committees and the Jury decline any responsibility to persons or goods, at sea or ashore, in consequence of participation in the competitions. The competitors and/or the parents or tutors shall contract all insurances required to cover every risk, included that to a third party.

SCORING SYSTEM:

Low-point scoring system will apply.

PRIZES:

First 10 Juniores of the ranking will be awarded.

First 3 Juniores female of the ranking.

First 5 Cadetti

First 3 Cadetti Female

ENTRIES:

Only Optimist (Juniores born 2008 – 2012 and Cadetti 2013 - 2014), 120€ per sailor till 1st March, entry paid at the venue 150€.

The registration will be open to all sailors (max 400 sailors in total) on our website (www.fragliavelariva.it).

ON-LINE ENTRY FEE: € 120 Fee paid by Paypal will be charged of the 5%.

Specifying class and sail number.

Entries will be accepted by the first come – first served principle and payment is mandatory at the moment of entry. No entry can be completed without payment. Maximum number of 400 participants.

CANCELLATION & REFUND

50% of the entry fee paid is refundable for cancellations received by the 1st of February. No entry fee is refundable after the 1st of March.

INSURANCE

Italian sailors and foreign sailors shall have third party insurance covering of not less than € 1.500.000,00 as per the new prescription of WS and the Italian sailing Federation (Prot 2015-1055).

All competitors at the registration are required to produce evidence of such insurance written in Italian or English and clearly indicating the name of the sailor(s) or the sailing number(s) or the IODA registry number(s) of the insured boat(s), including the starting date and ending date of the insurance and the euro/USD amount of the insurance.

If an insurance is issued to a sail number/IODA registration number, the competitor shall present a valid measurement certificate and will not be allowed to sail with a sail number different from the one printed on the measurement certificate.

SUPPORT BOATS AND MOTOR NAVIGATION:

Mechanically propelled boats are generally prohibited to run on the northern part of Lake Garda, however, during this event, a special permit to use such boats may be given. Support personnel having a boat, shall produce the following documents to the Organizing Authority:

- rib's engine registration document (engine brand name - engine serial numbers);
- rib's engine insurance;
- driver's identity document.

RIGHT TO USE NAME AND LIKENESS

In participating in the regatta any competitor automatically grants to the Organizing Authority and the sponsors of the regatta the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said regatta in which the competitor participates and in all material related to the said regatta without compensation.
