NOTICE OF RACE

"Regatta activities shall be carried out in accordance with the provisions concerning the fight against and the containment of the spread of Covid 19 issued by FIV, which the Organizing Authority shall be obliged to respect and enforce, and to which the participating members shall comply under the supervision of the Organizing Authority itself. Any cases of Covid 19 that may be detected during the event will be reported by the Organizing Authority to the relevant Health Authorities."

SP	Denotes a rule for which a standard penalty may be applied by the Race Committee or Technical Committee without a hearing, or a discretionary penalty applied by the Protest committee with a hearing. This changes RRS 63.1 and A5.1;
DP	Rules for which penalties are upon the Protests Committee. Depending on the seriousness of a breach of Covid-19 Italian Protocol, the penalty may be from a minimum of 10% to a disqualification.
NP	Rules that may not be ground of protests between boats (this changes RRS60.1(a)

1. RULES:

- 1.1 The race will be governed by the Rules as defined in the Racing Rules of Sailing (RRS) 2021-2024 and by the Normativa FIV per l'Attività Sportiva Nazionale 2023.
- 1.2 Class rules
- 1.3 The "PROCEDURE FOR REGULATION OF ACTION TO STRUGGLE AND CONTAIN THE SPREAD OF COVID-19 IN AFFILIATED SPORTS CLUBS AND ASSOCIATIONS", current version hereafter referred to as the "PROTOCOLLO". The penalty for a breach of the "Protocollo" shall be a maximum of 10%, depending on the seriousness of the breach committed. The percentage will be calculated with respect to the finishing position of the boat in all the races of the day in which the infraction was committed, or in case of an infraction while the boat is not racing, the penalty will be applied in the race nearest in time to that of the incident, as per RRS 64.2.
- 1.4 RRS 90.3(e) will apply.
- 1.5 App. T will apply
- 1.6 Ferries and public transportation have the right to pass





2. SAILING INSTRUCTIONS

Sailing Instructions will be available online within the 15th May 2023 at 20.00.

3. COMMUNICATION

The online official notice board is located at Racing Rules of Sailing: https://www.racingrulesofsailing.org/ NOR, SI and the Official Notices will be posted on the event website.

4. ELEGIBILITY AND ENTRY

The WS Eligibility Code will apply, if used by the class.

A boat entered in the regatta must meet the class rules for membership of the class association.

All members of Italian crews must have an Italian Sailing Federation membership card valid for year 2023 A valid insurance MUST BE SENT to info@fragliavelariva.it within the 10th May 2023.

Entry forms must be sent on-line through the website http://www.fragliavelariva.it/regatta

The entry form must be filled in paying attention to the unavoidable fields in red. All entries when confirmed will be displayed on the event website.

REFUND POLICY

Before the 30th of April the 50% will be charge back, no refund available after 30th April 2023 Since the Covid-19 is still an issue the Organizing Authority will provide a full refund in case of cancellation of the event, in case of postponement (if new dates don't fit for sailors) or if a competitor will not be able to reach the venue due to Covid 19 related issues (e.g. infection, quarantine, or other restrictions) beyond the control of the competitor.

6. ADVERTISING:

Advertising is permitted as for Class Rules and WS Regulation 20. Italian sailors displaying advertising must provide the FIV license.

7. SCHEDULE:

16th May at 13.00 First warning signal

17th May Race(s) 18th May Races(s) 18th May Prize Giving

Eight races are scheduled. Rescheduling of races may be made at the discretion of the Race Committee.

Races not completed as scheduled may be sailed at a later time or day during the championship.

However, not more than three races per day will be scheduled. Any changes to the start time will be posted on the Event Web site by 20.00 hrs of the preceding day.

No warning signal will be given after 16.00 hrs on the last day of the regatta.

10. EQUIPMENT INSPECTIONS:

- Each participating boat shall have and carry a valid Measurement Certificate.
- The Race or Technical Committee may check all yachts and crews before, during and after the races.
- Yachts and sails must be in conformity with the Rules of the Class Associations.

11. SCORING SYSTEM:

The Low Point scoring system of RRS Appendix A will apply.





When fewer than 4 races have been completed, a boat's series score is the total of her race scores. When 4 or more races have been completed, a boat's series score is the total of her race scores excluding her worst score. This change RRS A2.

12. SUPPORT PERSON VESSELS

Team leaders/coaches shall register at Secretary Office.

Team leaders/coaches shall comply with the following:

- to follow all instructions given by the Race Committee and by the Organizing Committee;
- to carry other coaches on board if necessary;
- not more than 2 coaches/trainers/parents are allowed on the same assisting rubber boat;
- Enter the clubhouse only after checking body temperature
- Access in nautic facilities only for Race Committee, athletes, measurers
- In closed spaces always wear masks
- Always keep social distance 1m
- The Organizing Authority reserves the right to assign a different area to each team
- Follow all the rules published by the Organizer, according to Italian and FIV regulations

Mechanically propelled boats are generally prohibited to run on the northern part of Lake Garda, however, during this event, a special permit to use such boats may be given. Support personnel having a boat, shall produce the following documents to the Organizing Authority:

- rib's engine registration document (engine brand name engine serial numbers);
- rib's engine insurance;
- driver's identity document

All the listed documents must be sent to info@fragliavelariva.it

The permit will be issued only for assistance to the races and training and it can be withdrawn at any time if rules for coaching as stating in the SI will be not followed. It is forbidden the navigation of private assistance boats on the right-hand side of the course looking south.

13. PRIZES:

Prizes will be awarded at least to the first three (3) placed boats. Eventually special Prizes will be posted on the notice board.

14. RISK STATEMENT:

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

It is up to parents, team leaders or support person to allow competitors to take part in the races and therefore they have to sign the declaration of participation on registration. Fraglia Vela Riva, the Race Committee, the Jury and all volunteers involved decline all responsibility regarding persons or goods, at sea or ashore, in consequence of participation in the competition.

ENVIROMENTAL RESPONSABILITY

It is recalled the Basic Principle which states: "Participants are encouraged to minimize any adverse environmental impact of the sport of sailing", it is recommended that care be taken to always protect the environment during and after the event. Especially attention is drawn to RRS 47 -TRASH DISPOSAL- which states: "Competitors and support persons shall not intentionally put trash in the water. This rule always applies while afloat. The penalty for a breach of this rule may be less than disqualification".





15. INSURANCE

All boats competing in the Riva Cup 2023 shall have third party insurance cover of not less than € 1.500.000,00 or equivalent thereof in any other currency for any accident.

All owners/competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover.
