



NOTICE OF RACE

Eurosaf European Championship
ETF 26 GP Riva del Garda
August 27th to 30th
Riva del Garda - Italy
Fraglia Vela Riva and the ETF26 Class

The breach of any rules within the Notice of Race that contain the notion "DP" may not, at the discretion of the jury, lead to automatic disqualification.

1. RULES

The regatta will be governed by:

Rules as defined in *The Racing Rules of Sailing (RRS) 2025-2028* and the ETF26 HSR 2025,

1.1. ETF 26 Class Rules and ETF26 Series 2025 Rules.

2. ADVERTISING [DP]

Boats shall be required to display advertising chosen and supplied by the Organizing Authority. If the Rule has been broken, the regulation World Sailing 20.9.2 applies.

3. ELIGIBILITY AND ENTRY

The regatta is open to all boats of the ETF26 Class.

Competitors (each crew member) having an official competition French license, shall present it during registration on September 4th or an official "adhesion" French license with a medical certificate (dated less than one year) certifying the absence of any medical objection to participate in sailing competition.

Foreign competitors (each crew member) not having an official French license shall present during registration:

- Evidence of their membership to a World Sailing Member National Authority,
- The measurement form or certificate of the boat,
- A valid third-party liability insurance with a minimum cover of €2.000.000,
- A medical certificate (dated less than one year) certifying the absence of any medical objection to participate in sailing competition,
- A parental authorization for the minors,
- Valid Class registration

4. REGISTRATION AND ENTRY FEE

5. SCHEDULE

On the last scheduled day of racing no warning signal will be made after 15.00 except in case of a general recall.

6. MEASUREMENT AND INSPECTION

All measurement and weigh-in will take place according to the above schedule.

All sails shall be certified in accordance with class rules and series rules.

7. THE COURSES

Courses will be decided according to the weather forecast.

8. SAILING INSTRUCTIONS

The Sailing Instructions will be posted on the Official WhatsApp Class.

9. RACING AREA

The racing area will be located in the Quiberon Bay, see Appendix 1.

10. DECISION TO RACE

The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone. See RRS 4. Consequently, accepting to participate in a race or to continue racing, the competitor disclaims the Organizing Authority and the Race Committee of any liability for damage (material and/or personal injury).



11. RIGHT TO USE NAME AND LIKENESS

By participating in this competition, a competitor automatically grants to the Organizing Authority and its sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or film television and other productions of him or her during the competition, without compensation.

12. RADIO COMMUNICATION [DP]

Except in case of emergency, a boat shall neither make voice or data transmissions while racing nor receive voice or data communication not available to all boats. These restrictions also apply to mobile phones.

13. SUPPORT BOATS AND COACHES [DP]

13.1. All support boats will be required to comply with RRS 3.

13.2. All support boats willing to be part of the safety organization shall be registered with the Organizing Authority and shall comply with national and local and race regulations. The Organizing Authority will reserve the right to accept or reject any late registration at its whole discretion.

13.3. All support boats registered in the safety organization shall clearly display the identification sign given by the Organizing Authority, at all times while at sea.
